

Minutes of the Board of Component Representatives Meeting

Welcome and Call to Order

- 1. <u>Call to Order</u>: Chair Dr. John Taylor called the meeting of the board of component representatives (BCR) to order at 1:30 p.m.
- 2. Establishment of Quorum: A quorum was established; see attendance sheet (attached).
- 3. Approval of the Agenda: The agenda was approved as presented.

- 1. <u>Chair Report</u>: The chair provided opening remarks and encouraged BCR members to update their BoardEffect user profiles.
- 2. <u>BCR Vice Chair Selection</u>: BCR selected Dr. Jennifer Gee Schoon-Tong to serve as vice chair for the 2024 term
- 3. <u>CDA Board of Directors Nomination Report</u>: BCR considered and supported the committee on volunteer placement's candidate recommendation for the CDA board of directors (CDA board) vacancy.
- 4. <u>Member Sentiment and Pressures on Organized Dentistry</u>: BCR received information regarding pressures being felt by member dentists and organized dentistry, and discussed the pressures that components are experiencing and how components and CDA can work together to alleviate shared pressures.
- 5. <u>BCR Chair Fiduciary Responsibilities</u>: The chair informed BCR that a discussion regarding the chair's fiduciary responsibilities will be discussed at the May meeting and encouraged BCR members to discuss this issue with their components in preparation for the meeting.
- 6. <u>Component Executive Director Guest Members</u>: BCR considered a request from the component executive directors to have more than three executive director guest members serve on BCR in 2024. BCR voted to support the request, to be forwarded to the CDA board for further consideration.
- 7. <u>Component Resources Subcommittee</u>: BCR discussed the work completed by the component resources subcommittee in 2023 and work planned for 2024, and agreed that the subcommittee's work should continue in 2024.
- 8. <u>Dental Assisting Training Grant</u>: BCR received information regarding the High Road Training Partnership grant that was awarded to the CDA Foundation, which will provide funding for dental assistant training initiatives.
